- 5. Electronic bids must be submitted to the office of Nepal Bank Limited, Head Office, General Services Department, Kathmandu Bagmati Province, through PPMO website www.bolpatra.np/egp on or before above mentioned date and time. Bids received after this deadline will be rejected.

The bids will be opened in the presence of bidders' representatives who choose to attend on above mentioned date and time at the Nepal Bank Limited, Head Office, General Services Department, Kathmandu, Bagmati Province, Nepal. Bids must be valid for the period of 90 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
