The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 p:m (for IFB No.NBL/NCB14/G078/79) & at 01:15 p:m (for IFB No. NBL/NCB29/G078/79) on 2079/03/20 at the office of Nepal Bank Limited, Head Office, General Service Department. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.4,05,000.00 (for IFB No. NBL/NCB14/G078/79) and NRs.4,00,000.00 (for IFB No. NBL/NCB29/G078/79) which shall be valid for 30 days beyond the validity period of the bid.
