4. Electronic bids must be submitted to the office of **Nepal Bank Limited, Head Office, General Services Department, Kathmandu** through PPMO website www.bolpatra.gov.np/egg on or before **11:00 hours** on **2079-04-06**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12 hours on 2079-04-06** at the office of **Nepal Bank Limited, Head Office, General Services Department, Kathmandu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid (**total 120 days**)
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
