2. Nepal Bank Limited invites electronic bids from eligible bidders **for Retrofitting & Renovation of Building No. 1, Head Office, Kathmandu** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 35,000,000.00 (Rupees Thirty Five Million only)**
  - Minimum Work experience of similar size and nature: **Participation as prime contractor, management contractor, or subcontractor, in at least ONE (1) contracts of Banks/Commercial/Institutional/Corporate/Government office buildings with retrofitting works within the last Ten (10) years, each with a value of at least NPR 12,700,000.00 (Rupees Twelve Million Seven Hundred Thousand only) with 13% VAT that have been successfully completed and that are similar to the proposed works.**
